### **At The Accident Scene**

- > Stay safe from traffic, fire, debris, and other risks
- > Remain calm, if possible. Check for injuries
- > Call 911 (even if it does not appear to be a serious accident) and ask for an ambulance
- > If you are safe, use this guide to obtain driver's information:
  - > Name
  - > Address
  - > Driver's license number
  - > Make and model of vehicle
  - > Vehicle registration number
- > Vehicle insurance company name & policy number (Please make sure the insurance information matches the vehicle invloved in the accident.)



- > Get names, addresses, & phone numbers of all witnesses before they leave the scene
- > Discuss the car accident **only** with the police
- > Write down the name of the police officer and the name of the officer's agency
- > Stay on the scene of the accident until the police finish their investigation
- > Write down the crash report number
- > Take photos, if you can



#### IF POSSIBLE, YOU SHOULD ALSO TAKE PHOTOS OF THE FOLLOWING:

- > Street signs, traffic controls, crosswalks
- > Skid marks or brake marks
- > Scattered debris

- > Any nearby damaged property
- > Conditions (weather, traffic and/or road)
- > Landmarks (street signs or address markers)
- > If necessary, call a towing company to remove vour car
- > If you are injured or hurt, seek medical treatment. Often times, it takes a couple of days before you begin to feel the pain from the accident



## **After You Leave The Accident Scene**

> Report your accident to your insurance company or agent. Do not provide a recorded statement to any insurance company without first consulting an attorney



> Call or consult an attorney (bring as much documentation as possible about your accident or your injuries)



> If necessary, obtain a rental vehicle and find a repair shop to take your damage vehicle to
